#### **General Notice**

Pursuant to Article XV Sections 73-75 of the Delaware Charter, sealed bids will be received by the City of Delaware, Ohio, Public Works Department, 440 E. William St., Delaware, Ohio, 43015 until **Thursday, January 13, 2022** at **11:00 a.m.** local time through the Bidding Website and opened immediately thereafter, for the following:

The Project includes the following Work:

Fiber optic cable conduit installation along US 36/SR 37 under Norfolk Southern Railroad Bridge. Conduit/duct bank is being placed for future fiber optic cable installation. This contract only installs the conduit, not fiber optic cable. The Owner intends to issue a Notice to Proceed on or before February 21, 2022. The required date for Substantial Completion is April 7, 2022.

The Issuing Office for the Bidding Documents is the City of Delaware Public Works Department, 440 E. William St. Delaware, OH 43015. Prospective Bidders may examine the Bidding Documents at the Issuing Office Monday through Friday between the hours of 8:00 a.m. and 3:00 p.m. The Issuing Office will only use the Bidding Website to provide electronic copies of the Bidding Documents to prospective Bidders.

Bids will only be received by the City of Delaware through the Bidding Website. As such, Bidders must register through the Bidding Website. Registration at the Bidding Website requires the creation of a digital ID which is used to digitally sign bids. It can take up to seven (7) business days to process your digital ID, so plan accordingly. Bidders must register with the Bidding Website as a plan holder, even if Bidding Documents are obtained from a plan room or source other than the designated Bidding Website in either electronic or paper format. The designated website will be updated periodically with addenda, lists of registered plan holders, reports, and other information relevant to submitting a Bid for the Project. All official notifications, addenda, and other Bidding Documents will be offered only through the designated Bidding Website. Neither Owner nor Engineer will be responsible for Bidding Documents, including addenda, if any, obtained from sources other than the designated Bidding Website.

Each bid must be accompanied by a Bid Guaranty meeting the requirements 153.54 to 153.57 of the Ohio Revised Code and as required by the Bidding Documents.
