

NOTICE TO BIDDERS

General Notice

Pursuant to Article XV Sections 73-75 of the Delaware Charter, sealed bids will be received by the City of Delaware, Ohio, Public Works Department, 440 E. William St., Delaware, Ohio, 43015 until **Friday, June 24, 2022** at **11:00 a.m.** local time through the Bidding Website and opened immediately thereafter, for the following:

The Project includes the following Work:

Construction of a 0.27-mile extension of Sawmill Parkway with a shared use path, one intersection, 16" water main extension, and 24" sanitary sewer extension. The project will also construct an additional 0.60 miles of proposed ditches to S. Section Line Rd. and stormwater retention facilities.

Obtaining the Bidding Documents

The Issuing Office for the Bidding Documents is the City of Delaware Public Works Department, 440 E. William St. Delaware, OH 43015. The Issuing Office will only provide copies of the Bidding Documents to prospective Bidders electronically using the Bidding Website "Bid Express" at https://www.bidexpress.com

Bids will be received by the City of Delaware electronically through the Bidding Website, only. All Bidders must register as a plan holder through the Bidding Website. As such, Bidders must register for an account through the Bidding Website in advance of submitting the Bid. All official notifications, addenda, and other Bidding Documents will be offered only through the designated Bidding Website. Neither Owner nor Engineer will be responsible for Bidding Documents, including addenda, if any, obtained from sources other than the designated Bidding Website.

Each bid must be accompanied by a Bid Guaranty meeting the requirements 153.54 to 153.57 of the Ohio Revised Code and as required by the Bidding Documents.

Pre-bid Conference

A pre-bid conference for the Project will be held on Tuesday, June 14, 2022 at 2:00 p.m. at the Public Works Department with an option to join remotely through the Microsoft Teams platform. Attendance at the pre-bid conference is encouraged but not required. The pre-bid conference details are included in the Instructions to Bidders.

No bidder may withdraw his/her bid within sixty (60) days after the actual date of the opening thereof. The City of Delaware reserves the right to reject any or all bids, to waive any informality and

to award the bid or bids to the lowest responsive and responsible bidder as deemed to be in the best interest of the City, as determined by the City Manager.
