Pursuant to Article XV Sections 73-75 of the Delaware Charter, sealed bids will be received by the City of Delaware, Ohio, at City Hall, 1 South Sandusky Street, Delaware, Ohio, 43015 until 11:00 a.m. local time on Friday, December 9, 2022. Bids will be opened immediately thereafter for the following:

The base bid for the Spring Street Demolition Project consists of demolition of two commercial buildings, including disposal, backfill, and compaction and site restoration (grading and seeding including straw).

Sealed bids shall be submitted to the City of Delaware Planning & Community Development Department, 1 South Sandusky Street, Delaware, OH 43015. Notate "Spring Street Demolition Project Bid" on the exterior of the bid envelope. Each bid must be accompanied by a Bid Guaranty meeting the requirements 153.54 to 153.57 of the Ohio Revised Code and as required by the Bidding Documents.

No bidder may withdraw his/her bid within sixty (60) days after the actual date of the opening thereof. The City of Delaware reserves the right to reject any or all bids, to waive any informality, and to award the bid or bids to the lowest responsive and responsible bidder as deemed to be in the best interest of the City, as determined by the City Manager.

This project is funded by the State of Ohio Department of Development (ODOD) Building Demolition and Site Revitalization Program. Bidder's attention is called to all of the requirements contained in this bid packet, particularly to state labor standards provisions, state prevailing wages, various insurance requirements, and various equal employment opportunity provisions.
