I would like to submit the following comment regarding tonight's Delaware City Council meeting regarding proposed re-development of the County's Channing Street property:

As a Delaware resident since 2002, and a 15+ year resident of Scottwood Court, I would strongly discourage the Council from approving rezoning of the County property to a 'Planned Mixed-Use Overlay District.' Since nearly ALL of the adjacent properties are single-family residential, I definitely feel PMU zoning for this property would be inappropriate for the area. Redevelopment of this property should be restricted to single-family residential use only, in keeping with the surrounding area. At most, only 'R-4 Single- and Two-Family Residential' use should be granted to match current surrounding zoning.
