Following the Governor's and CDC recommendation Boards and Commissions will not meet and the work of those Commissions and Boards will be delegated to city staff with City Council taking final action on recommendations. The ordinance also discusses the ability for the City Manager to declare a State of Emergency within the City of Delaware and if declared and Council is unable to meet with a quorum, the City Manager is granted specific powers that will enable him to keep the government running.

Chief Donahue provided an update regarding cases of the COVID-19 virus within the State of Ohio. Chief Pijanowski updated that there was a confirmed positive case in Delaware County. Mr. Shulman clarified that the ordinance does not provide the City with any additional powers than it currently has.

TITLE OF PROPOSED ORDINANCE/RESOLUTION:

A RESOLUTION AUTHORIZING THE CITY MANAGER TO AMEND THE LEASE WITH DELAWARE COMMUNITY SPACE, LLC TO DEFER PAYMENTS CONSISTENT WITH THE GOVERNOR'S EXECUTIVE ORDER 2020-08D.

BACKGROUND:

Delaware Community Space owner Matt Davis has requested rent relief due to the COVID-19 crisis. Please see his attached letter as submitted on April 9, 2020.

Governor Dewine signed Executive Order 2020-08D "Commercial Evictions and Foreclosures" yesterday, Wednesday, April 1. The intent of this order is to assist our small businesses in maintain solvency throughout the COVID-19 crisis.

Under sections 1 and 2:

- 1. Landlords are requested to suspend, for a term off at least ninety (90) consecutive days, rent payments for small business commercial tenants in the State of Ohio that are facing financial hardship due to the COVID-19 pandemic; and
- 2. Landlords are requested to provide for a moratorium of evictions of small business commercial tenants for a term of at least ninety (90) consecutive days.

I have attached a copy of the Governor's order for your reference.

Staff recommends that the City of Delaware defer lease payments from COhatch for the first floor and lower level of 18 E. William St. for 90 days beginning with the May

payment. COhatch has already paid for April. It also is recommended that the City divide the payments for May, June and July equally amongst the remaining months of 2020, so that the company does not experience a balloon payment at the end of the deferment.

REASON WHY LEGISLATION IS NEEDED:

COhatch is already losing tenants from the Delaware facility. However, any rent relief for the three months will be passed on to the remaining Delaware business tenants and members of the Delaware COhatch facility to provide rent and membership fee relief.

Due to the lease having been authorized by a resolution of City Council any adjustment of said rent must be done by a resolution of City Council.

WHEREAS, under the terms of the lease, the tenant is responsible for paying \$6,500 per month on or before the first day of the month which was designed to offset the City's initial investment in the development of the space; and

WHEREAS, the tenant has submitted a letter requesting assistance on April 9, 2020 due to the financial impact caused by the COVID-19 crisis; and

WHEREAS, the Governor has issued Executive Order 2020-08D, which encourages landlords to work out solutions involving suspension of payments between landlords and tenants to provide financial relief.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DELAWARE, OHIO THAT:

SECTION 1. City Council hereby authorizes the City Manager to execute and addendum to the CoHatch lease with the following terms:

- a. Rent during the COVID-19 Emergency or 90 days, whichever is longer, may be deferred
- b. A new payment schedule to incorporate deferred payments.

SECTION 2. That this resolution shall be in force and effect immediately upon its passage.

Dear Delaware City Council,

During this crazy and unique time, more than ever COhatch finds ourselves as a vital community resource and our goal is to help as many people as possible get through this tough time. I wanted to give you an update on our current status as well as request a rent deferral for 90 days per the Governor's recent request (so that we can pass on to our office tenants).

Current Status:

- We remain open for member only essential businesses, but have very limited staffing that is just focusing on making sure the facilities stay clean and that members comply with social distancing guidelines.
- We have retained all of our employees and have activated them as "paid volunteers" for or COhatch Delivers Program. This program has already impacted thousands of people's lives. It is being lead by Laurie Lendon (Delaware COhatch Manager)
 - o In the first 2 weeks, we have over 101 volunteers, 179 people called for help, have created over 398 cards/treats of encouragement for isolated seniors, have delivered 512 meals to front line workers or seniors in need, have developed a delivery program with the Worthington Resource Pantry, have completed over 149 help requests, have organized a large blood drive with Polaris that is really needed and all spots were taken.
- We have applied for the Payroll Protection Plan and believe we will be able to get this loan to pay for our employees.
- We have worked with our banks to pay interest only during this time period.
- We have created a direct line to apply for Grants/Loans with Telhio and have sent all the information to our members for the \$10,000 Loan Advance, the PPP, and the Emergency SBA Loans.
- We have allowed all month to month members freeze their account if they need it so they don't have to pay and they don't have to cancel so they can stay connected.

Issue:

• Numerous private office members need short-term help. Even though they have leases we are trying to help them defer their costs also so they can buy time to get Federal relief. We can only do so much without our landlords an banks deferring payments.

The Ask:

- Please defer our rent of \$6500 per month for 90 days. We will repay the whole amount over our lease.
- I commit to passing this benefit on to others in Delaware and our goal is to help everyone tread water during this time.

Executive Order 2020-08D

Commercial Evictions and Foreclosures

WHEREAS, COVID-19 is a respiratory disease that can result in serious illness or death, is caused by the SARS-CoV-2 virus, which is a new strain of coronavirus that had not been previously identified in humans and can easily spread from person to person. The virus is spread between individuals who are in close contact with each other (within about six feet) through respiratory droplets produced when an infected person coughs or sneezes. It may be possible that individuals can get COVID-19 by touching a surface or object that has the virus on it and then touching their own mouth, nose or eyes; and

WHEREAS, on January 31, 2020, Health and Human Services Secretary, Alex M. Azar II, declared a public health emergency for the United States to aid the nation's healthcare community in responding to COVID-19; and

WHEREAS, on March 9, 2020, testing by the Department of Health confirmed that three (3) patients were positive for COVID-19 in the State of Ohio. This confirmed the presence of a potentially dangerous condition which may affect the health, safety and welfare of citizens of Ohio; and

WHEREAS, on March 9, 2020, I declared a State of Emergency in Executive Order 2020-01D; and

WHEREAS, on March 22, 2020; the Ohio Department of Health Director signed a Public Health Order that required all individuals currently living in Ohio to stay at home or at their place of residence except as allowed in certain circumstances, such as for essential activities, essential governmental functions, or to participate in essential businesses and operations, to further increase social distancing and ensure that as many people as possible stay at home to slow the spread of COVID-19; and

WHEREAS, time limitations for criminal, civil, and administrative proceedings that were set to expire between March 9, 2020 and July 30, 2020 have been tolled though the enactment of Section 22 of Amended Substitute House Bill Number 197 of the 133rd General Assembly; and

WHEREAS, the Supreme Court of Ohio has provided guidance to local courts to temporarily continue eviction filings, pending eviction proceedings, scheduled move-outs, and the execution of foreclosure judgments; and

WHEREAS, under the federal Coronavirus Aid, Relief, and Economic Security (CARES) Act and prior federal directives, many residential properties have had a temporary period of suspension regarding evictions and foreclosures put into place; and

WHEREAS, the economic impacts of COVID-19 on Ohio businesses have been significant; and

WHEREAS, during this public health emergency, commercial evictions and foreclosures destabilize local economies and threaten designated essential businesses and operations; and

WHEREAS, a period of suspended, but not negated, rent payments for small business commercial tenants would provide temporary financial relief throughout this unprecedented pandemic; and

WHEREAS, a period of forbearance would provide a pause and would allow time for sensible solutions to be worked out between commercial real estate borrowers and lenders; and

WHEREAS, the actions of other states, such as California and New York, to shield their businesses from evictions and foreclosures place Ohio businesses in a competitive and economic disadvantage;

NOW THEREFORE, I, Mike DeWine, Governor of the State of Ohio, by virtue of the authority vested in me by the Constitution of the United States, specifically the implied police powers of the Tenth Amendment, the Constitution of the State of Ohio, Article III, Section 5, and the laws of this State do hereby order and direct that:

- 1. Landlords are requested to suspend, for a term of at least ninety (90) consecutive days, rent payments for small business commercial tenants in the State of Ohio that are facing financial hardship due to the COVID-19 pandemic; and
- 2. Landlords are requested to provide for a moratorium of evictions of small business commercial tenants for a term of at least ninety (90) consecutive days; and
- 3. Lenders are requested to provide commercial real estate borrowers with a commercial mortgage loan for a property located in the State of Ohio an opportunity for a forbearance of a term of at least ninety (90) consecutive days for said mortgage as a result of a financial hardship due to the COVID-19 pandemic; and
- 4. "Lender" as that term is used herein shall include any banking organization, bank holding company, credit union, mortgage broker, mortgage loan servicer, master or special servicer, mortgage revenue bond issuer, mortgage revenue bond holder, mortgage loan originator, owning or holding any mortgage loan secured by property

located in the State of Ohio, including commercial mortgage-back securities (CMBS) loans; and

- 5. "Forbearance" as that term is used herein shall mean an agreement to forbear from (a) the enforcement of any remedies following any monetary or non-monetary defaults arising as a result of the COVID-19 pandemic, including the filing of suit against any borrower, maker, co-maker or guarantor, the filing of foreclosure, appointment of a receiver, impounding of reserve or other funds deposited in accord with any loan or security documents, or termination of any license to use cash, or (b) sweeping and/or seizing any cash by reason of cash sweep trigger events regardless of a default or the existence of circumstances that may give rise to a cash sweep trigger event arising as a result of the COVID-19 pandemic, or (c) any requirement that a party waive any legal rights or admit any default arising as a result of the COVID-19 pandemic; and
- 6. Nothing in this Order shall be construed to negate the obligation of a small business commercial tenant to pay rent or restrict a landlord from recovering rent at a future time; and
- 7. Nothing in this Order shall be construed to negate the obligations of a commercial real estate borrower, but rather provide a pause and time for sensible solutions to be worked out among commercial real estate borrowers and lenders; and
- 8. Nothing in this Order shall be construed to suspend any federal or state law.

I signed this Executive Order on April 1, 2020, in Columbus, Ohio, and it shall take effect immediately and remain in full force and effect for ninety (90) days unless modified or rescinded by me before then.

TITLE OF PROPOSED ORDINANCE/RESOLUTION:

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ESTABLISH A COVID-19 UTILITY ASSISTANCE PROGRAM.

BACKGROUND:

The COVID-19 emergency has caused many city residents to lose their jobs thereby limiting the ability to pay for normal household costs including utility bills. In an effort to provide relief to residents experiencing economic hardship, a utility assistance program to provide financial relief to customers has been proposed.

REASON WHY LEGISLATION IS NEEDED:

This legislation has been proposed to reassure residents who have become recently unemployed due to the COVID-19 emergency and cannot pay their utility bill during April and May. Under this program the following initiatives will be instituted:

- Credit card convenience fees that are charged to customers when paying income tax or utility bills will be waived.
- Payment plans will be offered to customers allowing for additional time to pay monthly utility bills.
- \$100,000 in utility bill credits will be set aside to apply to customers that have become unemployed due to the COVID-19 emergency and an

- application process will be developed to allocate credits on a customer's account.
- The City will maintain a moratorium on water shutoffs as well as waiving any penalties or reconnection fees for non-payment during this emergency.

COMMITTEE RECOMMENDATION:

FISCAL IMPACT(S):

A waiver of the credit card convenience fee will translate into an increase in banking fees assessed to the three Income Tax Funds (General Fund, Fire/EMS Fund, and Recreation Income Tax Fund) as well as the four Enterprise Funds (Stormwater, Water, Wastewater, Refuse) in the amount of \$60,000 as these costs are currently passed onto the customer.

The \$100,000 in utility bill credits would be allocated between the four enterprise funds and would result in the decline of \$100,000 in revenue during the 2020 fiscal year. This portion of the assistance program would not result in an increase to expenditures.

RESOLUTION NO. 20-31

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ESTABLISH A COVID-19 UTILITY ASSISTANCE PROGRAM.

WHEREAS, Governor Mike DeWine declared a State of Emergency in Ohio (Executive Order 01-D); and

WHEREAS, City Manager R. Thomas Homan declared an Emergency for the City of Delaware, Ohio (Ordinance 20-25) on March 18, 2020; and

WHEREAS, the COVID-19 emergency caused many city residents to lose their jobs; and

WHEREAS, the City wants to provide reassurance to residents facing economic hardship who cannot pay their utility bills; and

WHEREAS, City Council wishes to make clear that citizens who are unable to pay their utility bills based on unemployment caused by COVID-19 are not required to pay their utility bills in April and May. This period may be extended if necessary. The City will work with those residents after the emergency period using the tools provided in the COVID-19 Utility Assistance Program described below.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DELAWARE, OHIO THAT:

SECTION 1. The City Manager is hereby directed to establish a COVID-19 Utility Assistance Program with the following elements:

- 1. The City will waive credit card fees for both Income Tax and Utility Payments to promote social distancing and reduce the economic burden on residents paying with credit card
- 2. The City will establish payment plans to provide additional time for people to pay their utility bills.
- 3. The City will set aside \$100,000 for potential utility bill credits to aid to people unemployed due to the COVID-19 pandemic. The City will develop a hardship application which will be used to allocate these credits.
- 4. The City will continue its current moratorium on water shutoffs during the emergency
- 5. The City will continue to add no late fees or interest during the emergency
