Update with Shelia Hiddleson, Health Commissioner - Delaware General Health District

Ms. Hiddleson reviewed recent COVID-19 statistics within Delaware County. Mrs. Keller questioned if the State of Ohio had provided the percentage positive numbers. Ms. Hiddleson informed Council that they continue to await the data. Ms. Hiddleson discussed that the recent testing site at the Second Ward Community Center had 3% positive cases out of the 448 test that were completed. She discussed that the highest group is from residents between the age of 20-29. Mrs. Keller provided information on a dashboard that was created by Ohio Wesleyan University on rates of infection from students there.

Update on Farmers Market В.

Homan discussed meeting with Main Street Representatives, City of Delaware staff and the Delaware General Health District. At the meeting it was discussed to wait until the end of August to reevaluate. He discussed the plan provided by Main Street Delaware on how they can safely set up the market in the downtown area. Mr. Homan discussed that there is no legislation action required by Council.

#### PUBLIC PARTICIPATION:

Caroline Pusateri Main Street Delaware Program Coordinator 20 East Winter Street Delaware, Ohio

Ms. Pusateri provided a map to demonstrate a layout for potential vendors at the Farmers Market. She discussed using the east side of Sandusky Street and wrapping around the corners on Winter Street. Ms. Bibler discussed that they would request that masks continue to be worn and encourage social distancing. Ms. Bibler will work with the Health Department on what is needed to keep residents safe. Hiddleson discussed the need to go over the plan with staff to make a determination and recommendation. She also discussed that the benefit to the fairgrounds with Main Street having control over the ingress and egress compared to public sidewalks. Mr. Farrell questioned about parking by vendors and if there was consideration of a street market. Ms. Bibler clarified that vendors are requested to not park along Sandusky Street and to park in the parking lots. Chief Pijanowski informed Council that staff discussed closing down streets for the farmers market, but that there were safety concerns related to truck traffic. Mrs. Keller discussed being contacted by downtown business owners that are wanting the farmers market to return to the downtown area. She discussed that the businesses have met safety requirements. Mr. Farrell discussed the need to focus on public safety and Main Street Delaware and the Health Department need to work together to make sure this can be maintained. Mayor Riggle voiced her desire to have the

farmers market return to the downtown area, but only if the Health Department feels that it safely can. Vice-Mayor Shafer also voiced his support in the farmers market returning downtown. shared that while visiting Toledo recently there was a downtown farmers market and that stated the plan looked good. Mr. Hellinger voiced that public health was a priority and that the declines in COVID is due to all the safety measures implemented.

Mr. Daughenbaugh discussed the safety protocals that businesses are required to follow and that there continues to be a decline in number of He discussed that the cancellation of people coming downtown. downtown events could show a measure that the downtown is not safe. He discussed the benefits of the DORA and have not resulted in spikes in COVID or cancellation of schools. He discussed that the DORA is for multiple days and hours a week and the farmers market is only one day a week for a few hours. He discussed the need to have downtown events to support the downtown business owners.

Jason McMahon Via Cisco Webex Home Stretch Apparel 29 North Sandusky Street

Mr. McMahon discussed that as a new business owner he did not realize how important the downtown events are. He discussed that safety measures are being followed by residents and businesses and voiced his support to have events returned to the downtown area.

Brian Blackburn Via Cisco Webex

Mr. Blackburn discussed his background as a medical data analyst. He discussed the benefits to masks but studies that have shown that they do not stop the virus. He provided information regarding surface transmission and herd immunity.
