I write to you as a citizen of our great city of Delaware, a healthcare worker, ordained clergy, and as a chaplain. Each day I care for patients with COVID, their families, and healthcare workers. I have lost count of the number of COVID deaths I have witnessed. Each patient has been someone's mother, father, grandparent, son, or daughter. The grief I have seen as they have taken their last breath, I've prayed a final prayer, and their loved ones have said goodbye, is grief that no one can imagine. For the lucky, a family member will be present as they take their final breath. Sometimes it's a nurse who holds their hand as they die, and sometimes it's me.

As a healthcare worker, I work each day not knowing what I will be exposed to; what I could bring home to my family. I wear proper PPE, as do my colleagues. We try to protect ourselves so we aren't spreading COVID to our families or community.

I share this with you because as people in positions of power, our healthcare workers need your support. In March and April, you called us heroes, clapped for us, and left messages for us. And we were grateful. However, now we are called liars, told we are sharing "fake news", and have even been told by locals that they don't want us dining at their restaurants.

Even more concerning is that these messages are also coming from people in positions of power. When councilwoman Lisa Keller posts on her political facebook page questioning numbers from the health department regarding cases, it casts doubt on healthcare workers living and working in this community. When she questions the accuracy of tests, again doubt is cast upon healthcare workers. When pressed by myself and others who live in this community about why she won't speak in support of healthcare workers, or guidelines to keep the community safe, she remains silent.

The healthcare workers who live in this community, who serve this and other communities across central Ohio daily, deserve your support. We are tired. We change clothes in parking lots so as not to bring COVID home to our families. Some are living away from family so they don't accidentally make them sick. We are struggling with lack of support from our community. We are working extra hours to save lives, and we are watching friends/coworkers/family become sick and even die. We are giving all we can.

When Jesus was asked what is the greatest commandment, he responded in Matthew 22 saying, "Love the Lord your God with all your heart and with all your soul and with all your mind. This is the first and greatest commandment. And the second is like it, love your neighbor as yourself." Councilmembers, I urge you to love your neighbors right now by showing your support for healthcare workers and encouraging our community to follow the healthcare guidelines recommended by the state.
